## AN ORDINANCE AMENDING FINES **RELATING TO ANIMALS**

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ROSEVILLE, ILLINOIS:

Section One. Section 4-3A-7 of the Roseville Municipal Code is hereby amended as follows:

PENALTY: Any person violating any of the provisions of this Article shall be fines not less than one dollar (\$1.00) hundred dollars (\$100.00) nor more than on hundred dollars-(\$100.00) five-hundred dollars (\$500.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

Section Two. Section 4-3B-7 of the Roseville Municipal Code is hereby amended as follows:

PENALTY: Any person violating any of the provisions of this Article shall be fines not less than one dollar (\$1.00) hundred dollars (\$100.00) nor more than on hundred dollars-(\$100.00) five-hundred dollars (\$500.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

Section Three. This ordinance shall be in full force and effect thirty (30) days from and after its passage and approval.
